


#### **Annual Dinner Held Virtually**

#### **FINANCIAL NOTES**

2021 was again a challenging financial year as Anthesis endured another year of the COVID-19 pandemic which limited our ability to return to full services in our programs and the challenges in recruiting and retaining staff during a nationwide hiring crisis impacted revenues. It appears as if much of this is finally behind us and we look forward to increased services in 2022 including the first phase of funding of the Rate Study that was approved in the 2021-2022 State budget. Although for 2021, our programs remained underfunded and most struggled to break even during the year.

Overall, the organization had a surplus of \$440K in 2021 due to full loan forgiveness of our Payroll Protection Plan (PPP) funds received in 2020 as part of the federal CARES Act. We were granted the \$820.9K funding in April 2020 and successfully used all the funding in the appropriate categories that led to full forgiveness of the loan by the SBA last year. Thankfully these funds were available, as well as Alternative Service Delivery funding from the Department of Developmental Services, which allowed the flexibility needed for Anthesis to survive these incredibly difficult 2 years.
