The Association has been in place for many years, but the only responsibilities of membership were to meet annually to vote in new Board Members and approve bylaw changes. These responsibilities are better suited for Anthesis' Board of Directors, so Association members do not face any potential liability issues and we have one cohesive governing body.

With the advice of Public Counsel, Anthesis has drafted new bylaws to remove the Association as the governing body of the organization. After approval of this change, the Board of Directors would be the sole decision-making unit.

On Wednesday, August 4, 2021 at 6:00 pm, we will host a final Association Meeting to vote to approve these new bylaws. Any stakeholder – family, care provider, community member, funder, or other interested party – is welcome to join the meeting and participate in the vote.

THE AHMANSON FOUNDATION

Over the past few years, Anthesis has worked diligently to revamp programs and change operations to adapt to new federal regulations. In 2020, The Ahmanson Foundation generously awarded Anthesis a grant of \$100,000 to assist us in continuing to serve individuals with disabilities as we focus on community-integrated activities. The funding was used for a newly installed elevator, which includes 2 sliding door entry points and ADA hands-free built-in phone in case of emergencies, a new FORD T150 transit van to transport participants to and from program and work sites, and necessary purchases related to the COVID-19 pandemic, including sanitation supplies, personal protective equipment, thermometers, and COVID testing.

LEGISLATION MATTERS

It is budget time again! Each year the passage of the California state budget seems to have unique challenges. The process has been smoother in the past decade, though, due to a 2010 state law that withholds legislator pay if a budget is not passed by 6/30 of each calendar year. Additionally, with the Democrats holding a supermajority in both houses, the process has avoided the normal partisan politics. In the last two years, however, the budget struggle has returned, and tough negotiations have resumed between the Governor's office and state lawmakers.

Last year, when California was deep into the COVID-19 shutdown, Governor Newsom forecasted a \$54 billion deficit. He proposed a budget that included many cuts, but state legislators submitted one that kept funding stable— with both sides anticipating federal relief. The state legislature won those negotiations and, thankfully, no cuts were needed for any programs.

This year, considering a \$100 billion dollar surplus, Governor Newsom and state lawmakers proposed differing scenarios for the 2021-2022 budget. Quite a turn-around in one year! The Governor is suggested a plan to spread this wealth among many sectorsbut, unfortunately, he did not propose any new money for programs servicing the intellectually and developmentally disabled (I/DD) communities. Thankfully, he did recommend permanently eliminating a few recession-era cuts that we have struggled with since 2008—but this funding should have been restored years ago. Further support for the disabled community has been sorely lacking in Governor Newsom's budgetary proposals.

Many members of the state legislature understand the plight of our industry and want to do more- and they acknowledge that California has been neglecting its duty to the disabled community for years. Their budget proposal included a provision that would fully fund the 2019 Rate Study. Commissioned by the state legislature, this study analyzed the funding system for I/DD services and discovered that our system was underfunded by at least \$1.8 billion. A down payment on that shortfall was passed in 2019. Yet, programs like Anthesis received only about 8% in additional funds for our programs. We are still grateful for that increase, but in their budget proposal, the legislature aimed to fully fund the remaining \$1.4 billion over 3 years. We completely

supported this plan and are happy to report that the Governor and Legislators agree to a budget at the end of June that included funding of the Rate Study over 5 years.

It was imperative that this funding pass— as our programs depend upon it. We could pay our staff a wage that is commensurate to the important work they do, create more training opportunities for our staff to collaborate with our participants, and ensure that person-centered activities are the continued focus of our mission. Due to the pandemic and systemic underfunding by the State of California, many programs have closed, and it is very difficult to retain and recruit staff. This year's state budget is an opportunity to help improve funding to the I/ DD system. We appreciate everyone who advocated for this important issue and thank the Governor and Legislators for this unprecedented funding augmentation.
