
# A NOTE FROM THE DESK OF MITCH GARIADOR...

#### **LEGISLATION MATTERS**

In 2019, Anthesis along with its advocacy partners throughout the State scored a huge victory in securing additional funding for our services. The new funding will take effect on January 1, 2020 and is long overdue. The victory was due to the grassroots efforts of so many who care deeply about services in California and now it is time to continue our fight for services.

In Washington D.C. the U.S. Congress has introduced legislation that would eliminate the regulations related to our 14c certificate which allows us to pay our disabled workers according to their own productivity rates. Individuals with disabilities are unable to compete with their non-disabled peers in a competitive work environment but with the use of a subminimum wage certificate, Anthesis and many other organizations can find employment opportunities because they are paid according their own productivity. This puts them on an equal playing field with other workers and allows an employer to receive full value of each worker rather than having to subsidize the disabled worker. The Federal 14c system that has been in effect since the 1930s and has allowed many individuals to have meaningful work experiences.

The two pieces of legislation working their way through Congress are H.R. Bill 582 and Senate Bill 150, called the "Raise the Wage Act". These bills are intended to increase the minimum wage at the Federal level but also include provisions that will eliminate the 14c certificate over a period of years. Although, there are many who feel it is a human rights issue that all individuals should earn minimum wage, the reality is that employers will not pay for services that they are not getting equivalent value for. The unintended consequence of eliminating the 14c certificate is that many hard-working disabled workers
