#### **LEGISLATION MATTERS**

The services that Anthesis provides are intrinsically dependent on the legislative process at both the State and Federal levels. This is primarily due to the funding that we receive to provide services to intellectually and developmentally disabled (I/DD) adults but goes beyond that by dictating how the services are provided. These regulations and guidelines include Title 17 & 22 of the California Code of Regulations. Home and Community Based Supports (HCBS) of community integration and person-centered thinking philosophy, community integrated employment at minimum wage or higher. community-based supports versus facilitybased programs and during the last 2 years an ever-changing array of guidelines to deal with the COVID-19 pandemic. It seems like everything we do has some basis in a legislative act and makes it difficult to maneuver through all the bureaucratic mazes.

Anthesis by itself could never navigate all of this without the support of our advocacy partners. Our management staff spend a great deal of time attending meetings sponsored by DDS, the regional centers, DOR and CCL to help us stay abreast of what is going on but need help at a higher level to advocate for changes and to prevent unwanted legislation from passing.

For that type of support, Anthesis relies on our facing in the legislative process.
