Andrew Behnke is the General Manager of Double-Tree by Hilton Claremont. Mr. Behnke has been a supporter of Anthesis for over 8 years and has two enclaves at the hotel, not to mention he has hired 3 individuals from the enclaves as direct employees. It is dedication and loyalty such as this that ensures the employment and success of the individuals Anthesis serves. Anthesis cannot express how grateful they are for the relationship that has been forged between the two organizations.

LEGISLATION MATTERS

In June, Governor Newsom and the California State legislature approved a much-needed rate increase for programs like Anthesis. This action was the result of some great grass roots advocacy work by many people throughout the State including the Anthesis Board, staff, participants, families and other supporters. The advocacy that was conducted proved that when united, the disabilities community can advocate for positive results. The amount of additional funding that was approved will greatly help our programs, but it is only regarded as a down payment towards fully funding the statewide system of services to the intellectually and developmentally disabled. According to a Rate Study commissioned by the legislature and completed by Burns & Associates of Arizona, our system is underfunded by \$1.2 billion dollars from the general fund. The additional funding would allow us to pay our staff, wages that would be commensurate to the important work they do and allow us to invest in our programs, thereby



ending the funding stagnation that has existed in our system for over 20 years. We truly appreciate the funding received in this year's budget process which is valued at \$250 million per year but it is only a fraction of the full amount that is needed to make the system whole. We are monitoring the progress of the Rate Study in the hopes that it will provide a framework for true reform of the funding system for services provided through the Department of Developmental Services and are working with our State advocates on next steps to ensure that we continue to make progress. We won a battle in 2019 but we have much work to do in order to win the war against inadequate funding to support the individuals in our programs who deserve so much more than they receive today. Stay tuned to this section of our new quarterly publication to be updated on the progress and sign up to receive our email blasts in order to participate in future grass roots advocacy efforts. Together we can make a difference to assist the individuals we serve.
